RE: FY 2012 Funding for International Education and Foreign Language Studies: The Higher Education Act, Title VI and Fulbright-Hays 102(b)(6)

Dear House and Senate Appropriations Committee Leadership:

The undersigned organizations of the Coalition for International Education appreciate your support for the U.S. Department of Education's international and foreign language education programs noted above. These programs sustained a \$50 million or 40% reduction in the FY 2011 Continuing Resolution. As you begin final work on resolving differences between the House and Senate versions of the FY 2012 Labor, HHS, and Education Appropriations Bill, we strongly urge you to safeguard these programs from further reductions by providing no less than the FY 2011 level of \$75.729 million provided in the Senate committee bill. This includes \$66.712 million for the Higher Education Act, Title VI-A&B; \$7.465 million for Fulbright-Hays 102(b)(6); and \$1.552 million for the Title VI-C Institute for International Public Policy.

Given the nation's severe economic, global and security challenges, maintaining a robust federal investment in these programs is vital to America's wellbeing. The nation continues to face a dangerously short supply of Americans with in-depth knowledge of world regions and international markets, and fluency in foreign languages and their cultures. These skills help to ensure our security and global economic competitiveness, including job creation and sustainable recovery from the economic crisis. The FY 2011 funding reductions already have weakened the educational opportunities needed to address these shortfalls, as well as to prepare our students for the 21st century global workplace.

For example, surveys on the impact of the FY 2011 cuts in the current academic year indicate:

- Reduction or cancellation of hundreds of less commonly taught language and area studies classes will affect over 6.300 students;
- Reductions in international business programs will result in over 4,300 fewer graduates with international business expertise and 10,000 fewer business professionals trained;
- Reductions in language resources and research will result in over 5,900 fewer language teachers trained, involving 29 languages of national need;
- ➤ Elimination of funding for overseas research will result in five centers located in strategic host countries closing their facilities or reducing activities, affecting thousands of U.S. scholars and study abroad students;
- ➤ Reductions in international and foreign language expertise outreach will force deep cuts to activities in K-12 schools, underrepresented populations, minority institutions of higher education, community colleges, businesses, as well as in federal, state and local agencies, including the military.

We also are deeply concerned that the House bill proposes to eliminate funding for the Fulbright-Hays overseas programs and the Title VI–C Institute for International Public Policy (IIPP) program in FY 2012. Distinct from the Department of State's Fulbright programs, the Department of Education's Fulbright programs serve as an essential overseas component to Title VI domestic programs, providing the necessary education abroad opportunities for American students and teachers to gain high levels of proficiency in national need languages and world areas. The Title VI–C IIPP provides critical support and fellowship opportunities to minority serving institutions to prepare a cadre of well-trained, language proficient minority students for international service, thus helping to ensure that those representing the U.S. around the world reflect the diversity that defines us as Americans.

We strongly urge that Congress hold the line from further funding reductions to these vital programs. Thank you for your consideration of our views.
