THE NATIONAL HUMANITIES ALLIANCE (NHA) is a nationwide coalition of organizations advocating for the humanities on campuses, in communities, and on Capitol Hill. Founded in 1981, NHA is supported by over 250 member organizations, including: colleges, universities, libraries, museums, cultural organizations, state humanities councils, and scholarly, professional, and higher education associations. It is the only organization that brings together the U.S. humanities community as a whole.

THE NATIONAL ENDOWMENT FOR THE HUMANITIES (NEH)

ACTION NEEDED

We urge Congress to provide robust funding in FY 2025 for the National Endowment for the Humanities.

APPROPRIATIONS SUBCOMMITTEE

The NEH is funded under the Interior, Environment, and Related Agencies Appropriations bill.

FUNDING OVERVIEW

Prior to an historic funding increase in FY 2023, the NEH had received small but steady increases in funding. Nonetheless the NEH's funding has decreased by more than 10 percent since 2010 when adjusted for inflation.

ABOUT THE NEH

The NEH's mission is to strengthen our nation by supporting high-quality projects and programs in the humanities and by making the humanities available to all Americans. Through its grantmaking programs, the NEH supports the preservation of cultural heritage, professional development for thousands of educators, cutting-edge research, and public programs that deepen understanding of history and culture. NEH grants reach every state and every congressional district.

INTERNATIONAL EDUCATION—TITLE VI AND FULBRIGHT-HAYS

ACTION NEEDED

For FY 2025, we urge Congress to provide at least \$85.7 million for the Department of Education's Title VI and Fulbright-Hays programs, including \$75.4 million for Title VI and \$10.3 million for Fulbright-Hays.

APPROPRIATIONS SUBCOMMITTEE

Title VI and Fulbright-Hays are funded under the Labor, Health and Human Services, Education, and Related Agencies Appropriations bill.

FUNDING OVERVIEW

While we have seen incremental gains for Title VI and Fulbright-Hays in recent years, the programs have not recovered from severe cuts in FY 2011. These cuts led to 22 percent fewer resource centers, 18 percent fewer undergraduate and doctoral fellowships, fewer training opportunities for students and teachers, and fewer outreach activities to government and business.

ABOUT TITLE VI AND FULBRIGHT-HAYS

Title VI and Fulbright-Hays are the Department of Education's international education programs. Title VI funds language and area studies on campuses around the country and Fulbright-Hays supports students and faculty to travel abroad for research. Together, these programs address the nation's critical need for world language and cultural expertise in fields such as foreign policy and business and reinforce pipelines for instruction in languages such as Arabic and Chinese, which are not commonly taught in high schools.

NATIONAL ARCHIVES AND RECORDS ADMINISTRATION (NARA)

ACTION NEEDED

We urge Congress to provide robust funding in FY 2025 for the operating expenses of the National Archives and Records Administration (NARA) and for the National Historical Publications and Records Commission (NHPRC), the agency's grantmaking arm.

APPROPRIATIONS SUBCOMMITTEE

The National Archives is funded under the Financial Services and General Government Appropriations bill.

FUNDING OVERVIEW

Increased federal spending for the National Archives is necessary to manage, preserve, and make accessible the federal government's records. Prior to FY 2023's significant increase in funding, NARA's budget had either decreased or been stagnant in recent years even as its responsibilities have grown. The NHPRC's budget has seen small increases in recent years, but its capacity has not recovered from major reductions after FY 2011.

ABOUT NARA

The National Archives and Records Administration preserves and makes accessible to the public the records of the U.S. Government. NARA coordinates all federal records issues, including declassification of federal records and compliance with the Freedom of Information Act, the Federal Records Act, and the Presidential Records Act. Its 40 facilities nationwide are used by American citizens who rely on access to immigration, naturalization, and census records to provide proof of citizenship and conduct genealogical research. Veterans and their families rely on military records to gain access to their benefits.

ABOUT THE NHPRC

As NARA's grantmaking arm, the National Historical Publications and Records Commission (NHPRC) supports projects that preserve the American documentary record, support the field of preservation, and connect Americans with archival resources.

INSTITUTE OF MUSEUM AND LIBRARY SERVICES (IMLS)

ACTION NEEDED

For FY 2025, we urge Congress to provide robust funding for the Office of Museum Services and for the administration of the Library Services and Technology Act.

APPROPRIATIONS SUBCOMMITTEE

The IMLS is funded under the Labor, Health and Human Services, Education, and Related Agencies Appropriations bill.

FUNDING OVERVIEW

IMLS funding has not yet recovered from deep cuts in 2011, though it received a significant increase in FY 2023 and modest increases in previous years. In 2018, Congress passed the Museum and Library Services Act to reauthorize the IMLS until FY 2025 and authorized increased funding for both museum and library services.

ABOUT IMLS

The Institute of Museum and Library Services (IMLS) is the primary source of federal support for the nation's 123,000 libraries and 17,500 museums. The mission of the IMLS is to inspire libraries and museums to advance innovation, lifelong learning, and cultural and civic engagement. Its Office of Museum Services (OMS) awards grants that support museums in their efforts to educate students and preserve and digitize collections. The IMLS also administers the Library Services and Technology Act (LSTA), which consolidates federal library programs while expanding services for learning and access to information resources.

HISTORY AND CIVICS PROGRAMS

ACTION NEEDED

For FY 2025, we urge Congress to provide robust funding for the U.S. Department of Education's History and Civics Programs.

APPROPRIATIONS SUBCOMMITTEE

History and Civics Programs are funded under the Labor, Health and Human Services, Education, and Related Agencies Appropriations bill.

ABOUT THE DEPARTMENT OF EDUCATION'S HISTORY AND CIVICS PROGRAMS

The Elementary and Secondary Education Act, signed into law in December 2015, includes funding for K-12 history and civics education—the only dedicated funding lines for these subjects. One funding line supports a grant program that promotes evidence-based strategies to encourage innovative American history, geography, and civics instruction, targeting schools that serve low-income students and underserved populations. Another funding line goes to Presidential and Congressional Academies for American History, intensive academies for teachers and students to learn more about civics.

LIBRARY OF CONGRESS

ACTION NEEDED

For FY 2025, we urge Congress to provide robust funding for the Library of Congress. The acquisition, management, and preservation of digital collections is an enormous task, and the Library must have adequate funds to manage and provide access to digitized and born-digital content.

APPROPRIATIONS SUBCOMMITTEE

The Library of Congress is funded under the Legislative Branch Appropriations bill.
